15/01533/OUTEIS – Outline planning application with all matters reserved for the demolition of all existing farm buildings (except farmhouse) and the development of up to 1800 dwellings, a local centre to include retail and a community centre, one 1 form of entry primary school, one 2 forms of entry primary school, associated highway infrastructure including two proposed vehicular accesses with the A4146, two proposed pedestrian and cycle bridge crossing the river Ouzel, multi-functional public open space, informal amenity space, children's play space, open space incorporating the scheduled monument, playing fields, allotments, surface water attenuation and strategic landscaping, and associated services and utilities infrastructure (cross boundary application with Aylesbury Vale District Council) at Land at Eaton Leys, Galley Lane, Little Brickhill.
